RUN INFORMATION

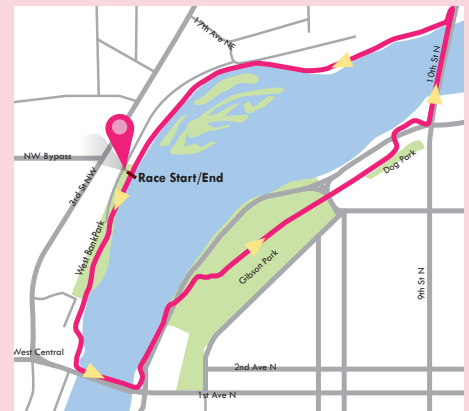
The race forms a 3.5 mile loop along River's Edge Trail, starting and ending in West Bank Park. The course is mostly flat with slight hills near the bridges and the dog park. The only place you cross the road is near the skate park. There will be one water station along the way (at the dog park) unless the temperature is below 30. Race will be chip timed. Runners and walkers are welcome. Please no dogs, bicycles, skates or skateboards.
